<b><u>"Unpublished price sensitive information" - UPSI</u></b>	
	Means any information, relating to a company or its securities, directly or indirectly, that is not generally available which upon becoming generally available, is likely to materially affect the price of the securities and shall, ordinarily include but not restricted to, information relating the following: <ul style="list-style-type: none"> <li>- Financial results;</li> <li>- Dividends;</li> <li>- Change in capital structure;</li> <li>- Mergers, de-mergers, acquisitions, de-listings, disposals and expansion of business and such other transactions;</li> <li>- Changes in key managerial personnel.</li> </ul>
<b><u>"Insider"</u></b>	
	Means any person who is: <ul style="list-style-type: none"> <li>- a connected person; or</li> <li>- in possession of or having access to unpublished price sensitive information</li> </ul>
<b><u>"Internal controls" includes;</u></b>	
	<ul style="list-style-type: none"> <li>- all employees who have access to UPSI are identified as a designated employee</li> <li>- all the UPSI shall be identified and its confidentiality shall be maintained</li> <li>- adequate restrictions shall be placed on communication</li> <li>- Confidentiality agreements shall be signed or notice be served to all such employees and persons</li> <li>- Periodic review to evaluate effectiveness by Audit Committee</li> </ul>
<b><u>"Disciplinary Action"</u></b>	
	means any action that can be taken on the completion of/during the investigation proceedings including but not limited to a warning, imposition of a fine, suspension from official duties or any such action as is deemed to be fit considering the gravity of the matter.
<b><u>"Disclosure of UPSI"</u></b>	
	means a concern raised by a written communication made in good faith that discloses the UPSI information it entails an obligation to make an open offer under

- The policy intends to cover serious concerns that could have a grave impact on operations and performance of the business of the Company;
- This policy is an extension of the NFP Sampoorna Foods Limited;
- Code of Internal Procedures and Conduct for Regulating Monitoring and Reporting of Trading by Insiders;
- Insiders should not act on their own in conducting any investigation activities;
- Any untrue allegations will not be taken up and investigated and appropriate action will be taken for the same;
- Appropriate and fair enquires and verification on market rumours;

## INVESTIGATION AND PROCEDURE OF INQUIRY

- Board of Directors authorise the immediate superior of the department and the Company secretary & Compliance Officer of the Company to initiate appropriate inquiries on becoming aware of leak of UPSI or suspected leak of UPSI and inform the Board promptly of such leaks, inquiries and results of such inquiries.
- How to Report:  
must report all suspected violations to
  - i. Your Immediate Superior
  - ii. CS and Compliance Officer

If you have reason to believe that your immediate supervisor or the Compliance Officer is involved in the suspected violation, your report may be made to the Audit Committee of NFP Sampoorna Foods Limited at:
